Notice of Race

1. RULES The regatta will be governed by the Racing Rules of Sailing (RRS) for 2013-2016, the Prescriptions of US Sailing, the ISSA Procedural Rules, the rules of the V-15 class, this Notice of Race (except if any of these are changed by the Sailing Instructions), and by the Sailing Instructions.

2. ELIGIBILITY, ENTRY & ENTRY FEE, REGISTRATION

- 2.1 This regatta is open to all High School Teams. Teams may enter by filing an entry with the Seattle Yacht Club Sailing Office using the accompanying Entry form.
- 2.2 Entry Fee: The entry fee is \$10.00 per competitor. Make checks payable to Seattle Yacht Club. Fee will include continental breakfast and lunch buffet.
- 2.3 Entry fee will be \$5 per sailor for teams who bring their own V-15. This discount will apply for up to four sailors per boat brought.
- 2.4 Schools may enter as many teams as they choose. If your school does not have sufficient sailors to form the necessary teams, you may "mix and match" sailors from different schools. If your school has more than one team, please enter as team 1, 2, 3 etc.

3. BOATS

- 3.1 Seattle Yacht Club will provide 12 Vanguard 15's. Please let us know if you can bring more Vanguard 15's.
- 3.2 Entries will be limited to twelve teams unless more boats can be brought by other organizations. Please notify Cameron Hoard, Seattle Yacht Club Coach, if you plan to bring boats by email at choard@gmail.com or phone at 206.926.1011.
- 3.3 The Regatta will be sailed with one division on the water at a time. If enough teams attend, teams *may* be separated into two fleets (each with A and B division), at the discretion of the Race Committee.
- 3.4 Rotations will be every 2 races from the end of either SYC Dock 4 or 2.
