

# **Tri-Island Series**

Protection Island Race – April 30, 2011 Vashon Island Race – May 14, 2011 Blake Island Race – June 4, 2011

## Sailing Instructions

#### 1 RULES

- 1.1 This regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS).
- 1.2 The prescriptions of US Sailing to the following rules shall apply: 34, 40, 48, 55, 60, 61.4, 63.2, 63.4, 64.3(b), 68, 70.5(a), 76.1, 76.3, 82, 86.3, 88.2, Appendix F, and G2. The text of these prescriptions is available from the US Sailing web site at www.ussailing.org.
- 1.3 A boat rated by her handicap class in consideration of water ballast may use water ballast as rated. This changes RRS 51.
- 1.4 Other changes to the rules may be noted elsewhere in the Notice of Race or Sailing Instructions. If the Notice of Race and Sailing Instructions are in conflict, the Sailing Instructions shall have precedence.

#### 2 NOTICE TO COMPETITORS

- 2.1 Notices to competitors will be posted on the official notice board.
- 2.2 The official notice board will be located at the south entrance of the Seattle Yacht Club Portage Bay clubhouse and optionally on the Seattle Yacht Club web site at www.seattleyachtclub.org. After the start of the Blake Island Race the official notice board will move temporarily to the Seattle Yacht Club clubhouse at Elliott Bay Marina and return to its original location the following day.
- 2.3 The race committee may provide unofficial communication at any time by hail or over VHF 72. Any communication not defined by the rules is unofficial communication. No aspect of unofficial communication, including content, timeliness, existence, or failure to hear, will be grounds for a request for redress. This changes RRS 62.1(a).

#### 3 CHANGES TO SAILING INSTRUCTIONS

- 3.1 Changes to the Sailing Instructions will be posted on the official notice board by 1800 on the day before it will take effect.
- 3.2 The race committee intends to repeat changes in Sailing Instructions on VHF 72 fifteen minutes before the scheduled time of the first warning signal each day. This announcement is unofficial communication per Sailing Instructions 2.3.

#### 4 SCHEDULE OF RACES

4.1 Races start on the following dates:

<u>Race</u>	<u>Date</u>
Protection Island	April 30, 2011
Vashon Island	May 14, 2011
Blake Island	June 4, 2011

- 4.2 The scheduled time of the first warning signal is 0900 each day.
- 4.3 No warning signal will be made after 1330.

#### 5 SIGNALS MADE ASHORE

5.1 There is no provision for signals made ashore.

#### 6 RACING AREA AND RACE COMMITTEE SIGNAL BOAT

- 6.1 The racing area is northern Puget Sound, Admiralty Inlet, and southeastern Straits of Juan de Fuca.
- 6.2 The starting line will be in Shilshole Bay in the area between Meadow Point and the Shilshole Bay Approach Buoy. Unless otherwise stated in the course description, the finishing line will be in the same vicinity as the starting line.
- 6.3 The race committee signal boat will be the Seattle Yacht Club *M/V Portage Bay*. If necessary, an alternate race committee signal boat may be used. The race committee signal boat will fly the Seattle Yacht Club burgee and a blue "R/C" flag.

#### 7 CLASSES AND CLASS FLAGS

- 7.1 The classes to race are PHRF Northwest handicap, including Cruiser/Racer, and one-design keelboat.
- 7.2 The classes, class flags, and course assignments are shown in Attachment A: Classes and Course Assignments.
- 7.3 Class assignments for registered boats will be announced as a notice to competitors issued by Thursday at 1800 before the first race. Subsequent changes to class assignments may be made with the same process as changes to the Sailing Instructions.
- 7.4 Class assignments for a late registrant may be made after the deadline for changes to the Sailing Instructions provided the boat flies her class flag from her backstay or the highest point on her stern while racing.



# Seattle Yacht Club

Established in 1892

7.5 The short course is available to boats rating 75 and slower. The sport boat course is open to boats 33 feet and less rating faster than 75.

#### 8 ADDITIONAL IDENTIFICATION

8.1 Boats may fly their class flag from their backstay or the highest point on their stern while racing. Boats may not fly a class flag for another class while racing.

#### 9 COURSES

#### Protection Island Race

Long Course: Start by leaving the starting mark to port, round Protection Island to starboard, and finish by leaving the finishing mark to port.

Short Course: Start by leaving the starting mark to port, round Double Bluff Lighted Buoy 1 (LL #16525) to port, and finish by leaving the finishing mark to port.

Sport Boat Course: Same as short course.

Cruiser/Racer Course: Start by leaving the starting mark to port, round a temporary mark located off the sound end of Whidbey Island at approximately 47° 53.0′ N, 122° 24.0′ W (47.88N 122.40W) to port, and finish by leaving the finishing mark to port.

#### Vashon Island Race

Long Course: Start by leaving the starting mark to port, round Maury Island and Vashon Island to starboard, and finish by leaving the finishing mark to port.

Short Course: Start by leaving the starting mark to port, round a temporary buoy north of Point Robinson at approximately 47° 24.0′ N, 122° 23.0 W (47.40N 122.38W) to port, and finish by leaving the finishing mark to port.

Sport Boat Course: Same as short course.

Cruiser/Racer Course: Start by leaving the starting mark to port, round Blakely Rocks ("K") to port, round the Duwamish Head Light ("D") to port, and finish by leaving the finishing mark to port.

#### Blake Island Race

Long Course: Start by leaving the starting mark to port, round Blake Island to port or starboard, round a temporary mark approximately 0.2 NM SSE of West Point Lighted Buoy 1 (LL #16805) to starboard, and finish by leaving the finishing mark to starboard. The

finishing line will be in the northern part of Elliott Bay near Elliott Bay Marina.

Short Course: Same as long course.

Sport Boat Course: Same as long course.

Cruiser/Racer Course: Same as long course, however, if the race committee displays flag "S" at the warning signal, start by leaving the start mark to port, round Decatur Reef Lighted Buoy 2 off Restoration Point (LL #16835) to port, round a temporary mark approximately 0.2 NM SSE of West Point Lighted Buoy 1 (LL #16805) to starboard, and finish by leaving the finishing mark to starboard. The finishing line will be in the northern part of Elliott Bay near Elliott Bay Marina.

#### 10 THE START

- 10.1 The starting line will be between a staff displaying an orange flag on the race committee signal boat and the course side of the starting mark.
- 10.2 If a general recall for a preceding class is signaled after the warning signal of a succeeding class, then the visual signals for the succeeding class will be removed and the start of the succeeding class will be considered abandoned without further signal.
- 10.3 If a boat is subject to RRS 29.1, Individual Recall, or RRS 30, Starting Penalties, the race committee may attempt to hail her sail number directly and/or on VHF 72. No aspect of the hail, including content, timeliness, existence, or failure to hear, will be grounds for a request for redress. This changes RRS 62.1(a).
- 10.4 A boat starting later than ten minutes after her starting signal will be scored Did Not Start (DNS). This changes RRS A4.2 and A5.
- 10.5 A boat whose warning signal has not been made shall avoid the starting area when other boats are racing but have not yet started.
- 10.6 The race committee signal boat may maneuver to hold position on the starting line at any time, including while anchored.

#### 11 THE FINISH

- 11.1 The finishing line will be between a staff displaying an orange flag on the race committee signal boat and the course side of the finishing mark.
- 11.2 The race committee may adjust or maintain the position of the finishing mark at any time without regard to RRS 33. If a race committee boat is attached to the finishing mark while boats are on the last leg of the course, that race committee boat shall display flag M as in RRS 34(b), but shall not be required to make repetitive sound signals. This changes RRS 33 and 34.



# Seattle Yacht Club

Established in 1892

- 11.3 The race committee signal boat may maneuver to adjust or maintain the size and orientation of the finishing line at any time, including while anchored. This changes RRS 33 and 34.
- 11.4 The race committee signal boat may display a flashing green and yellow light when on station at the finishing line after sunset.
- 11.5 Boats approaching the finishing line to finish after dark shall illuminate their sail number for identification.
- 11.6 If the race committee signal boat is missing at the finish of the Protection Island Race or Vashon Island Race, a boat finishes by passing within 100 yards offshore of the Meadow Point Buoy (LL #16765) when the buoy bears 090 degrees magnetic. If the race committee signal boat is missing at the finish of the Blake Island Race, a boat finishes by passing within 100 yards offshore of the platform on the Elliott Bay Marina breakwater when the platform first bears 340 degrees magnetic. If a boat finishes when the race committee signal boat is missing, to be scored as finishing she shall note her finishing time accurately to the second (e.g. using GPS time) and her finishing position in relation to any nearby boats and report them to the race committee as soon as reasonably possible. This changes US Sailing prescription to RRS 34.

#### 12 TIME LIMIT

- 12.1 Time limit is the maximum allowable time from each boat's starting signal to her finish time or a time of day. Boats that do not finish within their time limit will be scored Did Not Finish (DNF). This changes RRS 35.
- 12.2 Time limits for each race and course are as follows:

#### **Protection Island Race**

Long Course: 30 hours

Short Course / Sport Boat Course: 12 hours

Cruiser/Racer Course: 8 hours

## <u>Vashon Island Race</u>

Long Course: 19 hours

Short Course / Sport Boat Course: 12 hours

Cruiser/Racer Course: 7 hours

#### **Blake Island Race**

Long Course: Earlier of 8 hours or 1900

Short Course / Sport Boat Course: Same as long course

Cruiser/Racer Course: Same as long course

#### 13 PROTESTS

13.1 A boat intending to protest or request redress for an incident that occurred while racing must orally notify the race committee signal boat as soon as reasonably possible after retiring or finishing by hail or VHF 72 until she receives an oral confirmation from the race

- committee that the notification was received. This changes RRS 61.1(a).
- 13.2 For Protection Island Race and Vashon Island Race:
  - (a) Written protests and requests for redress must be delivered within the protest time limit to the front desk of the Seattle Yacht Club Portage Bay clubhouse.
  - (b) The protest time limit is at 1700 the Sunday after the start of the race.
  - (c) Hearing notices will be posted on the official notice board within 60 minutes after the protest time limit to inform parties to a hearing of the time and place of the hearing. Unless otherwise posted, hearings will be held on the Tuesday following the race at 1900 at the Seattle Yacht Club Portage Bay clubhouse. The posting of hearing notices shall be considered notice as required by RRS 63.2.

#### 13.3 For Blake Island Race:

- (a) Written protests and requests for redress must be delivered within the protest time limit to a representative of the protest committee located near the official notice board.
- (b) The protest time limit will be posted on the official notice board and will be 45 minutes after the completion of the race or 10 minutes after the posting of the time limit, whichever is later.
- (c) Hearing notices will be posted on the official notice board within 10 minutes after the protest time limit to inform parties to a hearing of the time and place of the hearing. Hearings may commence at any time if parties are present and prepared; otherwise, hearings may be scheduled as early as 10 minutes after the protest time limit. The posting of hearing notices shall be considered notice as required by RRS 63.2.
- 13.4 A boat may not protest another boat for an alleged breach of Sailing Instructions 10.5 and 11.5. This changes RRS 60.1(a).
- 13.5 Penalties under Sailing Instructions 10.5, 11.5 and 15 may be less than disqualification. This changes RRS 64.1(a).

#### 14 SCORING

- 14.1 Boats will be scored in class and course overall for each race and the series. Course overall scoring for monohulls and multihulls will be separate.
- 14.2 A boat that did not start (DNC, DNS, OCS), did not finish (DNF), retired after finishing (RAF), or is disqualified (DSQ, DNE, DGM, BFD) will be scored the number of finishers plus one. This changes RRS Appendix A4.2 and A9.
- 14.3 A boat's series score shall be the total of her race scores with no scores excluded. This changes RRS A2.
- 14.4 One race constitutes a series.



- 14.5 Corrected times for PHRF Northwest handicap classes will be calculated using the Time on Distance method.
- 14.6 If the race committee does not shorten course under RRS 32, Shortening or Abandoning after the Start, a shortened course option is available to boats on all courses that sail to a predetermined shortened course option finishing line (the "short line") and subsequently retire. Boats using this option must reach the short line within 80% of their full course time limit and report their finishing time to the race committee when they retire as per Sailing Instruction 15.2 within the full course time limit. Boats should record their shortened course finishing time accurately to the second (e.g. using GPS time) and at the time she finishes as per RRS definition of "finish" at the short line, except that as a boat approaches the short line for this purpose she must leave any mark that bounds the short line on the required side. Boats using the shortened course option will be considered finishers and will be scored in class and overall based on their time and the distance for the shortened course in sequence starting immediately behind boats finishing the full course that are not subject to Sailing Instruction 14.2. For races using handicaps based on time on distance, the distance will be based on the shortest navigable distance along the course to the short line. The location of the short line is as follows:

#### **Protection Island Race**

Long Course: A line on which the southwest high water corner of Protection Island bears 050 degrees magnetic.

Short Course / Sport Boat Course: A line on which the rounding mark bears 180 degrees magnetic.

Cruiser/Racer Course: A line on which the rounding mark bears 180 degrees magnetic.

#### Vashon Island Race

Long Course: A line on which the Point Robinson Light (LL #17070) bears 270 degrees magnetic.

Short Course / Sport Boat Course: A line on which the rounding mark bears 000 degrees magnetic.

Cruiser/Racer Course: A line on which the first rounding mark bears 000 degrees magnetic (use Blakely Rock Light).

**Blake Island Race** 

Long Course: After rounding the Blake Island mark, a line through the Decatur Reef Lighted Buoy 2 off Restoration Pt. (LL #16835) and to the Alki Pt. Light (LL #16915) on which Decatur Reef Buoy bears 262 or 082 degrees magnetic and Alki Pt. Light bears 082 degrees magnetic.

Short Course / Sport Boat Course: Same as long course.

Cruiser/Racer Course: Same as long course, however, if the race committee displays flag "S" at the warning signal, the short line is a line on which the first rounding mark bears 000 degrees magnetic.

#### 15 EQUIPMENT AND OPERATING REQUIREMENTS

- 15.1 Boats must check in with the race committee signal boat at the starting area each day before their first warning signal. Boats should check in by hail unless safety requires checking in by VHF 72.
- 15.2 Boats that retire from a race must orally notify the race committee as soon as possible after retiring by hail or VHF 72.
- 15.3 A boat racing in a handicap class must comply with one of the two following sets of equipment requirements, (a) or (b):
  - (a) Pacific International Yachting Association (PIYA)
    Special Regulations Governing Minimum Equipment
    and Accommodation Standards (PIYASR), as
    changed in the Notice of Race, according to the
    category requirement identified below. The text of
    these regulations is available from the PIYA web
    site at www.ussailing.net/piya.
  - (b) ISAF Offshore Special Regulations (OSR), without US Sailing prescriptions, as changed in the Notice of Race, according to the category requirement identified below. The text of these regulations is available from the International Sailing Federation (ISAF) web site at www.sailing.org/documents/special-regs.

#### **Protection Island Race**

Long Course: PIYASR II or OSR 3

Short / Sport Boat Course: PIYASR III or OSR 4 Cruiser/Racer Course: PIYASR III or OSR 4

#### Vashon Island Race

Long Course: PIYASR II or OSR 3

Short / Sport Boat Course: PIYASR III or OSR 4 Cruiser/Racer Course: PIYASR III or OSR 4

#### Blake Island Race

Long Course: PIYASR III or OSR 4

Short / Sport Boat Course: PIYASR III or OSR 4



Cruiser/Racer Course: PIYASR III or OSR 4

- 15.4 Boats must comply with U.S. Coast Guard regulations.
- 15.5 Boats must be operated in accordance with the Puget Sound Sailboat Safety Regulations, available from the Seattle Yacht Club web site at www.seattleyachtclub.org.
- 15.6 The race committee may inspect a boat at any time before or after racing for compliance with requirements.
- 15.7 A boat that uses its propulsion engine under RRS 1.1 and 42.3(f) or to move to a safe position if it is in danger of being run down by a vessel not participating in the race must either retire or file a request for redress. The request for redress must include the reason for using the propulsion engine and distance and direction traveled. When hearing the request for redress the protest committee will adjust the boat's time or score to remove any advantage that may have been gained in the race. This defines the circumstances in RRS 42.3(h) and changes RRS 62.1 and 64.2. This does not restrict a boat from requesting redress under RRS 62.1(c) for the same incident.

#### 16 RESPONSIBILITY

16.1 Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The responsibility for a boat's decision to participate in a race or to continue racing is hers alone. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

#### 17 AWARDS

17.1 The series awards party will be at the Seattle Yacht Club clubhouse at Elliott Bay Marina from 5 to 9 PM after the Blake Island race. The party will have free appetizers, a no-host bar, a live band, and participation prizes for each boat. Race awards will be presented for first place overall on each course. Series awards will be presented for first overall on each course and first, second, and third in class.
